2 Pursuant to Civil Local Rule 7-3(d)(2), Defendants provide this statement of recent decision
 3 informing the Court of a relevant judicial opinion published after the filing of Defendants' oppositions to
 4 Plaintiffs' motions. ECF Nos. 35, 36. In the attached opinion, the Southern District of New York granted
 5 summary judgment for agency defendants, and denied a motion for preliminary injunction, concluding
 6 that the plaintiffs there lacked standing to enforce grant agreements between the United States and
 7 nonparties, among other conclusions. Per Local Rule 7-3(d)(2), Defendants are barred from presenting
 8 argument in this statement, but counsel will be prepared to discuss the opinion at the upcoming hearing.
